raised from banks/infra NBFCs/bond markets, and 7-15 per cent from private developers' equity, external aid from multilateral and bilateral agencies and internal accruals of PSUs, the agency said.

There is a financing gap of 15-17% estimated, of which 6-8% is estimated to be bridged by asset monetisation and new development finance institutions (DFIs). The source of funding for the balance 10 per cent remains uncertain as of now, it added.
